Privacy Policy

Effective Date: March 18, 2026

KVB Ventures, LLC (“Company,” “we,” “our,” or “us”) operates the website villageco.work (the “Site”) and provides coworking membership services under the brand Village co.work. This Privacy Policy describes how we collect, use, and protect your personal information when you visit our Site or use our services.

By using our Site or services, you agree to the practices described in this policy.

1. Information We Collect

We collect information in the following ways:

a. Information you provide directly:

- Contact form submissions: name, email address, and any message content
- Newsletter sign-ups via Beehiiv: email address
- Membership booking via Zentry Pass: name, email, and payment information (processed directly by Zentry Pass — we do not store payment data)

b. Information collected automatically:

- Standard web analytics such as pages visited, referring URLs, browser type, and general location data (city/region level)
- Cookies and similar tracking technologies used for basic site functionality

c. Third-party embeds:

- Our Site embeds Google Maps, which may collect data per Google’s own privacy policy
- Our Site embeds Beehiiv newsletter signup forms, which process email addresses per Beehiiv’s privacy policy

2. How We Use Your Information

We use the information we collect to:

- Respond to contact form inquiries
- Send newsletter communications you have opted into via Beehiiv
- Process and manage your membership through Zentry Pass
- Improve our website and services
- Comply with applicable legal obligations

We do not sell, rent, or trade your personal information to third parties. We do not display advertising on our Site, and we do not allow advertisers to target you through our services.

3. Data Retention

We retain your information only as long as necessary to fulfill the purposes described in this policy or as required by law. You may request deletion of your data at any time by contacting us at admin@villageco.work.

4. Third-Party Services

Our Site and services rely on the following third-party providers, each governed by their own privacy policies:

- Zentry Pass — membership booking and access management
- Beehiiv — email newsletter platform
- Google Maps — embedded mapping

We encourage you to review the privacy policies of these providers directly.

5. Security

We take reasonable administrative and technical measures to protect your information. However, no data transmission or storage system is completely secure, and we cannot guarantee absolute security.

6. Children's Privacy

Our Site and services are not directed to individuals under the age of 18. We do not knowingly collect personal information from minors. If you believe we have inadvertently collected such information, please contact us immediately.

7. Your Rights
