Terms of Service

Effective Date: March 18, 2026

These Terms of Service (“Terms”) govern your use of the website villageco.work and your membership with Village co.work, operated by KVB Ventures, LLC (“Company,” “we,” “our,” or “us”). By accessing our Site or purchasing a membership, you agree to be bound by these Terms.

1. Use of the Website

You agree to use villageco.work only for lawful purposes. You may not:

- Use the Site to distribute spam, malicious code, or harmful content
- Attempt to gain unauthorized access to any portion of the Site or our systems
- Misrepresent yourself or impersonate any person or entity

We reserve the right to suspend or terminate access to the Site for any user who violates these Terms.

2. Memberships

Village co.work memberships are purchased and managed through our third-party booking platform, Zentry Pass. By purchasing a membership, you also agree to Zentry Pass’s applicable terms and conditions.

a. Access:

Upon completing your booking, you will receive a welcome email containing your access credentials. Access to the space is available 24 hours a day, 7 days a week via Apple Wallet pass or a personal access code provided at the time of booking. Access is granted immediately upon receipt of your welcome email.

b. Membership Terms:

- Memberships are billed on a monthly basis
- Membership benefits are personal and non-transferable
- Your access code and Apple Wallet pass are for your use only and must not be shared

c. Cancellation and Refunds:

Villageco.work handles cancellation and refund requests directly. Please email us at admin@villageco.work to manage your membership, cancellations, or refunds. Note that refunds cannot be given for months prior to the current month; only the current month and months moving forward are eligible.

3. Member Conduct

All members and guests agree to:

- Not conduct any unlawful activity on the premises
- Not bring unauthorized guests without prior arrangement
